- 1. Contractor shall submit following
 - 1.1 Caliper tool specification
 - 1.2 GPS unit specification
 - 1.3 Pigging sequence and procedure.
- 2. Contractor Shall confirm following
 - 2.1 If Pigging is done in the reverse direction (Compare to normal flow direction) the report shall be reversed.
 - 2.2 Deformation tool shall be multi-channel/sensor with electronic recording.
 - 2.3 The measuring unit may be mechanical or electronic or combination. The recording shall be electronic only.
 - 2.4 The tool shall be capable to pass through 25% diameter restriction and able to negotiate 1.5D bends.
 - 2.5 All bends shall be reported with radi, direction and degree.
 - 2.6 The tool shall be fitted with GPS mapping unit which shall report GPS Coordinates of all features, girth welds, anomalies, makers and like.
 - 2.6.1 The datum shall be WGS 84 and format shall be latitude, Longitude and elevation and measures.
 - 2.6.2 The elevation datum shall be Sea Level (MSL).
 - 2.6.3 The system accuracy shall be 0.8 meter minimum.
 - 2.7 The location accuracies shall be as follows.
 - 2.7.1 Circumferential locating accuracy shall be +/- 15deg.
 - 2.7.2 Axial accuracy between marker and Ref.grith weld or between makers/features shall be +/- 0.3%
 - 2.7.3 Axial accuracy between ref. girth weld and anomaly shall be +/-15cm.

2.8 The tool shall be capable to detect dents, Ovality, ID reduction, ID expansion, gross thickness (Change of Pipe schedule), bend radius, bend angle, type of valves, opening of valve, Tees ,offtakes, flanges, girth welds and other features as per the below table. The filled up cells are the minimum required. The contractor shall fill up the reaming cells and submit to KOC for review and approval.
